BILLS & TREASURER'S REPORT

A discussion was had as to why there are payments of taxes to Grand Rapids listed in the budget. A motion was made by Dick Patmos and supported by John Strick to approve the Treasurer's Report. The motion passed.

DIRECTOR'S REPORT

A. Jamestown Fire Dept. is to take care of Library snow plowing of the sidewalks. The Fire Dept. will bill the Township for the service. A suggestion was made to have a supply of salt in reserve.

- B. Copy Machine Services A motion was made by Larry Walton and supported by John Strick to proceed to order two printers and one color copy machine at \$420.50 per month from Noordyk Business Equipment. The motion passed.
- C. Library Statistics- 3200 checkouts in November. Internet usage is up (84) from last year (54).
- D. Meijer Proposal Director Stephanie has completed the final copy of the library's proposal to Meijer and will send the document to them.
- E. A motion was made by Larry Walton and supported by Dick Patmos to contract Matt Hull for a Virtual Tour of the Patmos Library at \$120.00- a one-time fee. The motion passed.
- F. 2018-2019 Library Budget The cost of yearly operations of the library is \$184,360.20 which is over the projected budget for 2018-2019 at \$178,942.98.
- G. Daily Operating Budget-Contracted Services- A discussion was had to cut down expenses from three services from the Operating Budget. This includes, Mike's Pest Control, Monthly Website Development Fee, and renegotiate the Cleaning Service to every other week instead of every week. A motion was made by Larry Walton and supported by Dick Patmos to discontinue Mike's Pest Control Service-effective immediately. The motion passed.
- H. Expense Budget (Jamestown Township Donation) A discussion was had to ask the Jamestown Township for an annual subsidy of \$20,000 for the library's upcoming fiscal year.

\$6000 has not been reimbursed to the Library by the Township as of this date.
